- 1) This project is to update the original buildings metal siding matching the existing new addition.
- 2) All bids shall be placed in a sealed envelope and marked “Replacement of Metal Siding-Wascott Fire Department”.
- 3) Mail bids to Wascott Fire Department, PO Box 111, Wascott, WI 54890. Bids are due by Noon, Monday, April 30, 2012. Bid opening shall be at 4:00 p.m. April 30, 2012, at the Wascott Fire Department Hall, 7607 E County Road T, Wascott, WI 54890
- 4) Bids may be considered for acceptance for a period of 30 days after the bid opening. The Bid must comply with all material requirements of the bid invitation and specifications. The Fire Department reserves the right to reject any bid determined to be nonresponsive. The Fire Department reserves the right to reject any or all bids or portions of bids as determined to be in the best interest of the Fire Department.
- 5) A written notice of award will be given to the successful bidder. The bidder(s) are required to execute the public contract and furnish required certificates of insurance within ten (10) calendar days from the date of the notice of award.
- 6) Payment shall be made within 30 days of receipt of a properly completed invoice or receipt and acceptance of the property or service.
- 7) During construction, any wall opened up shall be closed at the end of the day. Contractor shall keep project area clean and safe during and after working hours.
- 8) A “walk-through” is scheduled for Monday, April 23, 2012 from 9:00 a.m. to 3:00 p.m. at the Fire Department. If you have any questions, contact Mark Hanson at 715/466-4002.

**Specifications – Scope of Work**

- 1) The work shall consist of furnishing all materials and equipment.
- 2) Contractor agrees to begin project on or about June 18, 2012, and complete work on or before August 1, 2012.
- 3) Explain any special methods you propose and disclose any specifications you cannot meet. Alternative bids may be submitted, but must be clearly marked as "Alternative Bid".
- 4) NORTH WALL
  - a. Remove existing siding; replace lower treated purlin if needed; insulate wall; install new metal siding matching the existing new addition; trim pieces.
- 5) WEST WALL
  - a. Remove existing siding; replace lower treated purlin if needed; insulate wall; wrap overhead door jambs with new brake metal, J trim and drip cap; reinstall stops on overhead doors; install new metal siding matching the existing new addition; install all trim pieces.
- 6) SOUTH WALL
  - a. Remove old metal siding; remove small gable roof over service door at East end of wall; remove old service door and frame at East end of wall and frame in opening; replace lower treated purlin if needed; insulate wall; wrap all overhead door jambs with new brake metal, J trim and drip edge; reinstall stops on all overhead doors; fabricate new metal trip pieces for service door; install new metal siding matching the existing new addition; build small shed dormer over service door; extend roofline of office addition 4 feet to create a new shed dormer over main entrance.
