We, the undersigned town board of supervisors of the Town of Wascott, in the County(ies) of Douglas, Wisconsin, in accordance with the provisions of Chapter 24 of the Wisconsin Statutes, do hereby make application for a loan of Seventy Eight Thousand Seventy Two And 00/100 Dollars (\$78,072.00) from the Trust Funds of the State of Wisconsin for the purpose of financing the purchase of an ambulance.

The loan is to be continued for a term of 10 years from the 15th day of March preceding the date the loan is made. The loan is to be repaid in annual installments, as provided by law, with interest at the rate of 3.25 percent per annum.

We agree to the execution and signing of such certificates of indebtedness as the Board may prepare and submit, all in accordance with Chapter 24, Wisconsin Statutes.

The application is based upon compliance on the part of the Town with the provisions and regulations of the statutes above referred to, as set forth by the following statements which we do hereby certify to be correct and true.

The meeting of the Town Board of the Town of Wascott, in the County(ies) of Douglas, Wisconsin, which approved and authorized this application for a loan was a regularly called meeting held on the 4 day of 0 cto ber 2015.

At the aforesaid meeting a resolution was passed by a majority vote of the members of the Town Board approving and authorizing an application to the Board of Commissioners of Public Lands, State of Wisconsin, for a loan of Seventy Eight Thousand Seventy Two And 00/100 Dollars (\$78,072.00) from the Trust Funds of the State of Wisconsin to the Town of Wascott in the County(ies) of Douglas, Wisconsin, for the purpose of financing the purchase of an ambulance. That at the same time and place, the Town Board of the Town of Wascott by a majority vote of the members, adopted a resolution levying upon all the taxable property in the Town, a direct annual tax sufficient in amount to pay the annual installments of principal and interest, as they fall due, all in accordance with Article XI, Sec. 3 of the Constitution and Sec. 24.66(5), Wisconsin Statutes.
