**Ordinance 2013-04**  
**Amendment to Ordinance 2010-01**  
**Ordinance to Regulate the**  
**Placement of Snow on Roadways**  
**SECTION 2. Costs and Penalties**

The Town Board of the Town of Wascott, Douglas County, Wisconsin, do ordain the amendment to Ordinance 2010-01, Sec 2. Costs and Penalties, shall increase the penalty for violation of this ordinance from \$50 to \$100 as follows:

**SECTION 1. PLACEMENT OF SNOW ON ROADWAYS REGULATED**

There shall be no placing of snow on any roadway in the Town of Wascott that would create a hazardous condition for vehicle travel, and persons shall not plow snow across the roadway from their driveway.

**SECTION 2. COSTS AND PENALTIES**

In the case of plowing snow across a roadway, the property owner shall be solely responsible for this action. Anyone adjudged to have violated any provision of this Ordinance shall, upon conviction thereof, forfeit **\$100**, together with the costs of prosecution for each offense. Failure to pay any forfeiture hereunder, shall subject such violator to the alternate penalties provided for in Section 800.095 of the Wisconsin Statutes, as amended from time to time. Each violation, and each day of violation that continues, or occurs, shall constitute a separate offense. No provision of this Ordinance shall be construed to preclude the Town from maintaining any action to abate, prevent, or remove a violation of any provision of this Ordinance.

**SECTION 3. ENFORCEMENT AND BOND**

This Ordinance may be enforced by a Town Board Supervisor of the Town of Wascott, or the Douglas County Sheriff's Department issuing a citation pursuant to the provisions of this Ordinance, as amended from time to time.

**SECTION 4. SEVERABILITY**

The several sections of this Ordinance are declared to be severable. If any section or portion thereof, shall be declared by a court of competent jurisdiction to be invalid, unlawful or unenforceable, such decision shall apply only to the specific section or portion thereof, directly specified in the decision, and shall not affect the validity of any other provisions, sections or portions thereof, of the Ordinance. The remainder of the Ordinance shall remain in full force and effect. Any other Ordinances whose terms are in conflict with the provisions of this Ordinance, are hereby repealed as to those terms that conflict.

**SECTION 5. EFFECTIVE DATE**

This amended Ordinance shall take effect immediately upon passage and posting or publication as provided by law.
